Dr. Ahasanul Hoque, Associate Professor, Department of Genetics and Plant Breeding & House Tutor, Isha Khan Hall, BAU, Mymensingh is granted earned leave on full average pay for 90(ninety) days from 01.07.2026 to 28.09.2026 for traveling to different Countries for religious purposes as mentioned below:

2. He shall be bound to return in this University and resume his duties after expiry of his sanctioned leave otherwise compensation will be realized from his/his surety.
3. If he applies for leave/interruption while staying abroad while on leave and not joining the University service, the date of leave/interruption shall be fixed in his favor on the previous day of the last sanctioned leave i.e. his last working day in the University;
4. In case of breach of the conditions of the bond executed, the amount of salary allowance received/to be received during the period of educational leave shall be refundable from his with 15% simple interest. The period of employment during which there is no salary allowance in accordance with Government Decisions/Rules, leave shall not be counted as period of employment. That is, the period during which the appointing authority refunds/withdraws the salary allowances shall not be treated as pensionable service;
5. If, after joining the University as a self-employed person after joining the university as per the terms of the executed bond, he applies for voluntary retirement/interruption without completing the period for which he is committed to serve, in that case, the period he will serve shall be adjusted proportionately to his. The salary will be with drawn from his and the pension case will be settled as per Government/University rules after determining his actual length of service accordingly;
6. Government service rules, pension rules, circulars, office orders, instructions and decisions issued by the Government of the People's Republic of Bangladesh from time to time adopted by the University shall be applicable;
7. If he does not return to the University in due course, the University authorities may recover his one-time pension and the entire amount of his status in the Provident Fund to compenaste his outstanding bond. He will have no objection to it and his heirs in his absence will have no objection and objection will not be legally admissible;
